Trading Terms

All Transactions are strictly 30 days from the date of the invoice. Freight is not inclusive in costs of goods. The customer shall pay interest on all amounts outstanding in excess of 30 days at the rate of 3% per month, together with any costs associated with collecting the amount outstanding, including legal & collection charges. Cash/Cheque sales must be paid for and cleared before delivery.

Acceptance of Terms & Conditions

The placement of an order by the customer constitutes acceptance of these terms and conditions as the sole basis of the sale of goods to the exclusion of any conditions of purchase appearing on any document of the of the customer. Modifications of these conditions expressed in any document will not apply unless expressly accepted by Palm Beach Collection in writing.

Placing Orders

Please ensure all details regarding product name, colour, size and your deliver address are given.

Cancellation of Orders

Orders accepted by Palm Beach Collection can only be cancelled by notification in writing by the customer which must be confirmed with the written consent of Palm Beach Collection. Palm Beach Collection will only accept cancellation of orders that have not been shipped. Special items not considered as standard inventory by Palm Beach Collection will not be accepted for return by Pam Beach Collection.

Availability of Goods

Some product lines are seasonal and once stock is sold they will no longer be available.

Delivery

Unless specifically requested, all deliveries within Australia will be made by road freight. The delivery times made known to the customer are estimates only and Palm Beach Collection will not be responsible for late delivery and non-delivery.

Payment of Account

When accounts are outside the terms of trade of 30days, no further orders will be excepted until the account is settled.

Property in Goods

All property in and title to the goods shall remain vested in Palm Beach Collection until all goods supplied have been paid for in full by the customer. Until such time, the relationship between the parties shall be fiduciary and the customer shall hold the good as bailee for Palm Beach Collection. In the event that the goods are sold by the customer prior to Palm Beach Collection receiving payment in fill, the proceeds of the sale of the goods shall belong to Palm Beach Collection and they shall be held on trust for Palm Beach collection.

If the customer does not pay for any goods by the due date stated on the invoice, then Palm Beach Collection is irrevocably authorised by the customer to enter the customer's premises and use reasonable force to take possession of the goods without liability for the tort of trespass, negligence or payment of any compensation to the customer whatsoever.

Limitation of Liability

The customer acknowledges that no warranty, condition, description or representation in relation to the goods is given by Palm Beach Collection, either expressly or implied. All warranties, terms and conditions in relation to the state, quality or fitness of the goods and of every other kind whether implied by use, statute or otherwise is hereby excluded to the fullest extent permitted by law and in event shall Palm Beach Collection be liable for special or consequential damages.
